A tax rate of 0.515463 per \$100 valuation has been proposed by the governing body of CITY OF PALM VALLEY.

The no-new-revenue tax rate is the tax rate for the 2020 tax year that will raise the same amount of property tax revenue for CITY OF PALM VALLEY from the same properties in both the 2019 tax year and the 2020 tax year.

The voter-approval tax rate is the highest tax rate that CITY OF PALM VALLEY may adopt without holding an election to seek voter approval of the rate, unless the de minimis rate for CITY OF PALM VALLEY exceeds the voter-approval tax rate for CITY OF PALM VALLEY.

The de minimis rate is the rate equal to the sum of the no-new-revenue maintenance and operations rate for CITY OF PALM VALLEY, the rate that will raise \$500,000, and the current debt rate for CITY OF PALM VALLEY.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that CITY OF PALM VALLEY is proposing to increase property taxes for the 2020 tax year.

A public hearing on the proposed tax rate will be held on September 15, 2020 at 6:00pm at 1313 STUART PLACE RD STE 100; PALM VALLEY TX 78552.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, CITY OF PALM VALLEY is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the 0 of CITY OF PALM VALLEY at their offices or by attending the public meeting mentioned above.
