PALM VALLEY CITY COUNCIL MINUTES REGULAR MEETING March 15, 2022

- 1. **CALL TO ORDER** The meeting was called to order by Mayor Rivera.
- 2. **PLEDGE OF ALLEGIANCE** The Pledge of Allegiance followed led by Mayor Rivera.
- 3. LEGISLATIVE PRAYER The Legislative Prayer was recited by Councilman Hoff.
- 4. **PUBLIC COMMENTS** None
- 5. MINUTES OF THE REGULAR MEETING OF FEBRUARY 15, 2022, APPROVED

With no corrections to be made, Councilwoman Taylor made a motion to approve the minutes.

Councilman Galvan seconded the motion.

Mayor Rivera took the votes and the motion carried unanimously by all present.

6. LETTER OF RESIGNATION FROM CITY SECRETARY ACCEPTED

With minor discussion, the City Council accepted the letter of resignation presented by the City Secretary, Sylvia Trevino. Her effective date of resignation is June 3, 2022.

It was noted that when her replacement is hired and goes through the training, he/she will be paid a salary at the same time as the City Secretary, producing two payrolls, which will then require a budget adjustment.

Mayor Rivera stated that he has selected a small committee with Human Resources background to review the applications when submitted. The Committee consists of Dale Dillon, John Topp, and Gloria Garza.

Councilman Hoff made a motion to accept the resignation.

Councilman Wade seconded the motion.

Mayor Rivera took the votes and the motion carried unanimously by those present.

7. MAYOR RIVERA AUTHORIZED TO PROCEED TO ADVERTISE JOB ANNOUNCEMENT FOR THE POSITION OF CITY SECRETARY AND TO CONDUCT INTERVIEWS.

Mayor Rivera presented a timeline of actions to follow for the advertising, interviewing, and hiring of a City Secretary.

Advertising will be submitted to the Texas Municipal League and the Statewide City Secretaries' network. Mayor Rivera stated that he would also be reaching out to the Lower Rio Grande Valley Development Council.

Councilman Galvan commented that the long list of responsibilities calls for a City Administrator and he would like to see the position change to City Secretary/City Administrator.

Councilman Wade made a motion to proceed with advertising the position for a City Secretary/City Administrator.

Councilwoman Thompson seconded the motion.

Mayor Rivera took the votes and the motion carried unanimously by those present.

Councilwoman Taylor asked Chief Garcia the status of law and order in the community. Chief Garcia replied that all has been rather quiet, although, there was a report of a car burglary.

Councilwoman Taylor briefly mentioned the tragedy she experienced with the loss of her Chihuahua and complimented the officers who were so considerate and diligent in dealing with the situation when her Chihuahua got loose.

Mayor Rivera commented that the budget is doing well and is on track for this time of the year.
