### 9. GIFTS OF APPRECIATION PRESENTED TO OUTGOING COUNCIL MEMBERS CYNTHIA THOMPSON AND MICHAEL GALVAN

Councilman Wade presented the gifts of appreciation for both Councilmembers for their years of service to the City of Palm Valley. Councilwoman Thompson exited the meeting.

(At this time the newly elected city officials took their seats at the table)

#### 10. MAYOR PRO TEM APPOINTED FOR 2022-23

Councilwoman Baker nominated Councilman Lucio to serve as Mayor Pro Tem.

Councilman Hoff commented that while he realizes Councilman Lucio has a very impressive resume it would be tough for him to support someone with no experience in municipal government, however, he would fully support him for Mayor Pro Tem next year.

There was no second to the motion by Councilwoman Baker.

Councilwoman Taylor made a motion to appoint Councilman Hoff as Mayor Pro Tem being he has served the Council longer.

Councilman Wade seconded the motion.

Mayor Pro Tem Galvan took the votes and the motion carried unanimously by those present.

The motion carried 3 to 1.

(At this time, Mayor Pro Tem Galvan exited the meeting and newly appointed Mayor Pro Tem Hoff presided over the remainder of the meeting).

### 11. RESOLUTION APPROVED DESIGNATING SIGNATORIES FOR TRANSACTIONS WITH THE CITY'S BANKING DEPOSITORIES

Councilman Wade made a motion to approve the resolution.

Councilwoman Taylor seconded the motion.

Mayor Pro Tem Hoff took the votes and the motion carried unanimously by those present.

# 12. RESOLUTION TO APPOINT A MAYOR FOR THE REMAINING UNEXPIRED TERM OF LESS THAN ONE YEAR PURSUANT TO THE TEXAS LOCAL GOVERNMENT CODE SECTIONS 22.001 ET SEQ (EXECUTIVE SESSION IF NEEDED)

City Attorney Mann recommended that the Council proceed with Item No. 15 and take up Item No. 12 later in the meeting.

### 15. CHANGE ORDER #1 FOR LAKE #3 PROJECT APPROVED

Councilman Wade made a motion to approve the Change Order as recommended by David Flinn in the amount of \$24,147.00-----a decrease to the net contract price. The original amount of the contract was \$654,480. The revised contract amount incorporating this change order is now \$630,333.00.

David Flinn further explained the project with regards to the pumps and the pipes.

Councilman Wade commented that the low lake levels are also due to intermittent water delivery by the Harlingen Irrigation District and the demand for irrigation water. There had been no delivery of water in the last three weeks.

Councilwoman Baker added that low water levels are not a bad thing as there is space for stormwater to go to prevent flooding.

Councilwoman Baker seconded the motion.

Mayor Pro Tem Hoff took the votes and the motion carried unanimously by those present.

Councilwoman Baker made a motion to remove the position of City Administrator pursuant to Texas Local Government Code 22.077(B).

Councilman Lucio seconded the motion.

Mayor Pro Tem Hoff took the votes and the motion carried unanimously by those present.

## 14. ACTION TAKEN TO APPOINT A CITY SECRETARY PURSUANT TO TEXAS LOCAL GOVERNMENT CODE, SECTION 22.001 ET SEQ.

Councilman Lucio made a motion to reappoint City Secretary Sylvia Trevino through December 31, 2022, with a prorated salary of \$70,000 effective immediately for the remaining months.

Councilwoman Taylor seconded the motion.

Mayor Pro Tem Hoff took the votes and the motion carried unanimously by those present.

There being no further business, the meeting adjourned at 7:10 p.m. upon a motion by Councilman Wade and a second by Councilman Lucio.
